**KEYNOTE: "Forgotten Survivors: Sexual Violence and the Promise of the Human Rights Movement"** Sexual violence in detention represents one of the most egregious and common human rights violations in the United States. Multiple issues of oppression coalesce to create a group of extremely vulnerable survivors who are often forgotten by the various groups that might

serve them. The human rights movement offers a model that combines the best of the anti-oppression, civil rights, and empowerment approaches used by movements for social justice throughout this century. This talk will look at the progress we have made in bridging the gaps, building coalitions, and what had come of this work as well as the hope that the current progress brings for the future.

**PRESENTER: Linda McFarlane**, MSW, LCSW, Mental Health Program Director, Stop Prisoner Rape. Linda has worked with survivors of sexual violence in a variety of settings throughout the last two decades. Ms. McFarlane is the former Director of Counseling Services for the Sexual Assault Crisis Agency in Long Beach, California. She has served as a counselor and advocate for children and youth in both foster care and detention. In 1995, Ms. McFarlane was instrumental in implementing a ground-breaking treatment program for mentally ill incarcerated teen girls in Detroit, Michigan. She has worked in crisis intervention with a variety of populations including survivors of domestic violence and child abuse, teens and adults living with mental illness, and people living in poverty and with addictions. Ms. McFarlane is a graduate of the University of Michigan School of Social Work.

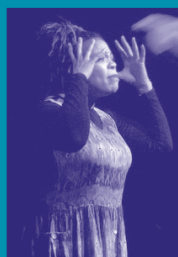
